

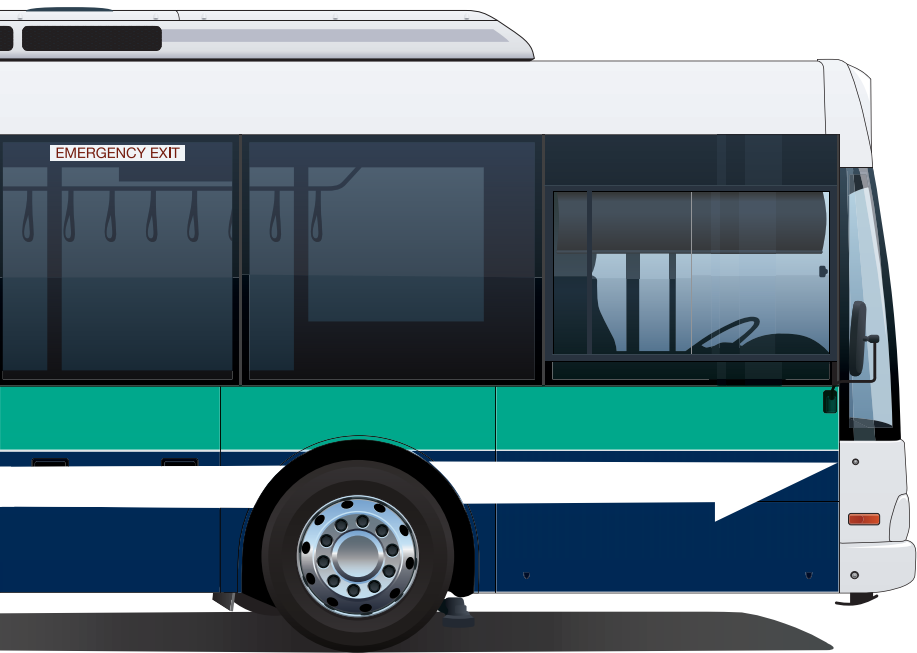

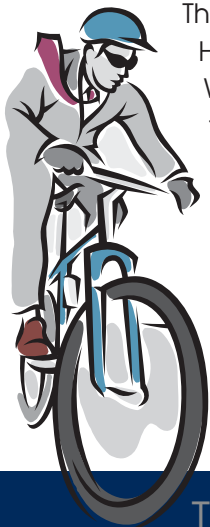


Incident Management Task Force

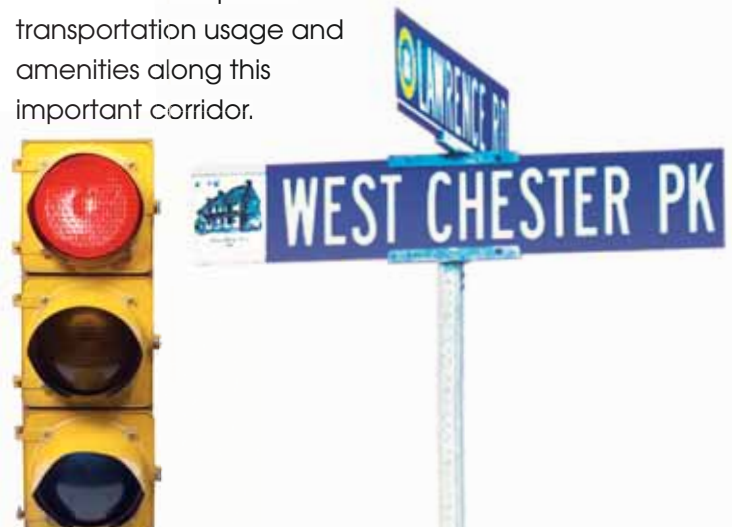
Municipalities Conference & Trade Show

The theme of this year's conference was Stormwater Management and featured a panel discussion with industry experts and keynote remarks by State Senator John C. Rafferty, Chairman of the Senate Transportation Committee. Transit Signal Priority on Rt. 3/West Chester Pike

In an effort to increase the number of riders on SEPTA's Route 104 bus, improve service quality and reduce traffic congestion along the West Chester Pike (PA Route 3) corridor, the DCTMA coordinated a Transit Signal Priority Feasibility Study. Working with Jacobs Engineering, the DCTMA was able to provide valuable information and recommendations to municipalities and stakeholders for how to improve traffic flow and public transportation usage and amenities along this important corridor.



Travel Instruction

The DCTMA's Travel Instruction program is designed to assist senior citizens and persons with disabilities with becoming more familiar with their transportation options and making the transition from private automobiles to using public transportation.



Travel instruction can enhance an individual's ability to live within their community and access all it has to offer.

Delaware County Employee Commuter Challenge & Commuting 101

This special initiative, supported by Delaware County Council, is designed to increase the use of alternative commuting methods by County employees. County employees have been challenged to increase their use of public transportation, carpooling, walking and cycling over driving to work alone. The DCTMA is also providing new employees with a review of their commuting alternatives through the Commuting 101 presentation.

Customized Solutions – Including corridor and traffic studies, parking management solutions, and English as a Second Language transit information.
