#### Indemnification Agreement

At their sole cost and expense, the exhibitor will, during the entire service period covered by this agreement, produce and maintain the following insurance coverage:

- Worker's Compensation, Occupational Disease Insurance and Employer's Liability Insurance;
- Public Liability and Property Damage Liability, including coverage for contractual liability and (where sub-contractors are involved) Contractor's Protective Liability with a combined single limit of not less than \$300,000 for bodily injury and/or property damage per occurrence; and
- When any motor vehicles are used in connection with the work to be performed, Automobile Public Liability Insurance with a combined single limit of not less than \$300,000 for bodily injury per occurrence.

Certificates evidencing the above coverage and naming Delaware County Transportation Management Association (DCTMA) as an additional named insured should be furnished to DCTMA upon request. All policies must be endorsed to provide that the Insurance Company shall give thirty (30) days written notice to DCTMA in the event said policies are to be terminated or changed in such manner as would affect, in any way, the insurance requirements of this Agreement.
